# **YOU BOOKED YOUR TRIP. ACT TODAY TO PROTECT IT...AND YOURSELF!**

### **TRIP CANCELLATION**

Can reimburse unused, nonrefundable, pre-paid trip payment/deposits for cancellations due to covered circumstances, such as injury, sickness, death, strike, inclement weather or terrorist incidents.

### **TRIP INTERRUPTION**

Can reimburse unused, nonrefundable, pre-paid trip expenses for land or water arrangements and the cost of additional transportation expenses when trip is interrupted due to unforeseen circumstances covered by the plan.

### **TRIP DELAY**

Can reimburse pre-paid, non-refundable payments for land or water travel arrangements as well as reasonable additional expenses if your trip is delayed 12 hours or more due to a covered reason, including carrier-caused delays and inclement weather.

### **SINGLE OCCUPANCY SUPPLEMENT**

If your traveling companion cancels their trip for a covered reason, and you decide to go alone, you may be reimbursed for the additional cost incurred as a result of a change in the per person occupancy rate.

### **MISSED CONNECTION**

Can reimburse pre-paid, unused land and water travel costs arrangements and additional transportation costs to join your trip, if you miss your trip departure, because your arrival at the trip destination is delayed for 6 hours or more due to a covered reason.

### **ACCIDENT & SICKNESS MEDICAL EXPENSE**

Can pay for covered medical expenses incurred as a result of injury or sickness that first manifests or occurs on your trip. Covered medical expenses can include prescription drug costs, medical treatment or services ordered by a physician, as well as emergency dental treatment (subject to a lower limit).

### **MEDICAL EVACUATION AND REPATRIATION OF REMAINS**

If you incur a sickness or injury that is acute, severe or life-threatening, this reimburses transportation expenses incurred to transport you to the nearest medical facility where treatment is available. If you are hospitalized for more than 3 consecutive days following or unable to travel due to an emergency medical evacuation, the plan can cover costs incurred to return your child/children who were accompanying you to your primary residence in the U.S. or can cover reasonable expenses for someone from home to visit while you recover (if you are traveling alone). This can also cover the cost of returning remains home (in the event of death). Arrangements for this benefit must be made through On Call International.

### **BAGGAGE AND PERSONAL EFFECTS/BAGGAGE DELAY**

Under the Baggage and Personal Effects Benefit, the plan reimburses you if your property is lost, stolen, damaged or destroyed during your trip. Under Baggage Delay, the plan reimburses for necessary personal items, if baggage is delayed for at least 12 consecutive hours.

### **\*PRE-EXISTING CONDITION EXCLUSION WAIVER**

Waives exclusion for pre-existing conditions, provided you

- Purchase the plan within 21 days of the date your initial payment/trip deposit is received, and
- Are not disabled from travel at the time of purchase.

### **NON-INSURANCE SERVICES\***

#### **ON CALL INTERNATIONAL**

Includes assistance services such as arranging emergency medical services/evacuations, medical monitoring, and 24-hour access to travel agents for help with emergency travel arrangements such as rebooking flights and making hotel arrangements.

#### **CONCIERGE**

Includes services such as restaurant referrals/reservations, theater/concert and sporting event arrangements.

### CANCEL FOR ANY REASON (CFAR) OPTION\*\*

If you meet all additional requirements, this reimburses up to 75% of pre-paid, forfeited, nonrefundable trip payments and deposits, if trip is canceled for any reason not otherwise covered by the plan.

### STILL WORKING?

This plan offers coverage for numerous work-related circumstances that might require you to cancel or interrupt your trip. Covered reasons include involuntary transfer of employment, involuntary employer termination or layoff, a merger or acquisition of your company requiring you to work and more.

### EARLY PURCHASE ADVANTAGE

Purchase your Travel Plan within 21 days of the date your initial trip deposit/payment is received, and you'll be eligible for a Pre-Existing Medical Condition Exclusion Waiver and a Cancel for Any Reason Upgrade.

### BUY NOW FOR MAXIMUM BENEFITS

Your Trip Cancellation benefit begins at 12:01 am on the day after the date you purchase your plan.
